

GFMD Closing remarks on 16 May 2014 by Ambassador Eva Åkerman Börje

Excellencies, Distinguished Guests, Dear Colleagues,

As we close this year's Forum Meeting, and thereby the Swedish GFMD Chairmanship, I would like to mention in brief some of the advances made, but I would also like to spend some time on outstanding issues. Areas where there is still room for improvement and continued efforts.

For ease of reference, let me stick to the three "D:s" of our Chairmanship. A more development oriented, dynamic and durable forum.

[Development focussed]

With regards to the **development focus of the Forum**. Great progress has been made in shifting the dialogue from a migration-centred approach, to an approach that has taken development objectives as a point of departure – How migration can contribute to inclusive economic and social development, for the migrants themselves, their families as well as countries of origin and destination.

The inclusion of migration in the post-2015 development agenda lies at the heart of this endeavour. On this issue, important progress has been made, and a summary of our deliberations in this regard will be communicated to relevant stakeholders. But looking ahead, much more needs to be done, as we move beyond the work of the Open Working Group on Sustainable Development Goals. Sweden is truly grateful that Turkey has expressed its commitment to furthering this effort.

[More Dynamic]

With regards to making the **forum more dynamic**, we have agreed, in the Future of the Forum Session, on new terms of references for the Troika, Steering Group and Friends of the Forum. The need to strengthen the capacity of the Support Unit for the future has been addressed.

We have found a new format for the engagement with the substantive discussions. Through agreeing to form Government Teams for each roundtable session at an early stage in the process, and holding thematic meetings directly linked to the topics discussed



in these roundtables greater government ownership and expertise from capitals can be injected into the dialogue.

This is encouraging progress, but it is not enough. Since the forum remains voluntary and informal, **states need to step up to the challenge of truly leading the forum**. The Swedish Chair experimented with forming expert networks for each roundtable session. The results have been mixed.

As the Forum evolves, the Swedish Chair would therefore suggest to heed the call from the High-level Dialogue for **closer coordination and collaboration with the Global Migration Group**. The five areas highlighted by the Special Representative of the Secretary General would go a long way in this regard – ranging from the identification of shared priorities to collaboration in voluntary follow-up and implantation.

If the GMG could assist the Chair of the GFMD, Government Teams and individual countries as suggested, discussions could be enriched and participating governments could be empowered to engage more constructively. The last point, on assisting countries in the voluntary follow-up and implementation could mean to include migration in the development analysis, plans and programmes. This would be a big step in moving from words to action.

Looking at other stakeholders, the GFMD has explored and developed a format for **engaging with the private sector**. This seems to have been appreciated by most stakeholders and it is encouraging to see that Turkey is taking this issue forward during their Chairmanship.

One area that needs further **improvement is the communication**. The Swedish Chair has operated a Twitter account and through the Support Unit, more importantly, we have managed to get the Policy and Practice Database in place, but through a communication plan we could reach much further.

[Durable]

Finally, I should touch on the durability of the Forum. At the Future of the Forum earlier today, we agreed on a new **long-term financing mechanism** as well as the format for a **multi-annual work plan**. Together these tools will increase transparency, predictability and facilitate the work of incoming chairs. Nonetheless, funders of the process remain limited in number. There is an urgent need for more governments to



prove their commitment to the process through making financial contributions, regardless of how small these may be.

Finally, recalling that the GFMD is more than a meeting, that it is in fact an ongoing year-long process of meetings and exchanging experiences and lessons learnt, I must thank **all of those who have worked with us over the past 18 months** and for the faith that you vested in Sweden during our Chairmanship.
