





Cooperation Strategies among States to Address Irregular Migration: Shared Responsibility to Promote Human Development

San Salvador, El Salvador October 4-5, 2011

Objectives

The agenda for the GFMD thematic meeting in El Salvador 4-5 October flows from recommendations made in Puerto Vallarta regarding joint strategies in addressing irregular migration. States highlighted the need for shared responsibility between countries of origin, transit and destination, as well as respect for the human rights of migrants, regardless of immigration status. Other recommendations included the need for States to highlight the contributions made by regular as well as irregular migrants in the host country, including through public awareness campaigns to this effect. Finally, the recommendations emphasized the need for coordination and cooperation amongst States regarding information sharing, and for focusing on the protection of vulnerable migrant groups including irregular migrants.

The specific objectives of this meeting are to:


- Exchange information on bilateral, regional and international practices designed to protect migrants in an irregular situation.
- Identify conditions and mechanisms for sustained and effective partnerships between countries of origin, transit and destination in order to reduce the risks and vulnerabilities of migrants in an irregular situation.

Methodology

The discussion and outcomes are expected to highlight practical examples of cooperation mechanisms and activities between States and non-State actors to address the issue of irregular migration including, expanding regular migration channel opportunities, combating xenophobia and increasing protection measures for migrants overall, among others.

To guide the discussion towards concrete outcomes, the meeting will focus on the following questions posed to countries of origin, transit and destination:

- How can more regular migration channels mitigate irregular migration and its negative consequences for human development?
- How can migrants and their families be best protected from the risks of irregular migration?











 What information and research do we need to fully understand and address irregular migration from a development perspective? How do we best collect, analyze and share this information?

The meeting is broken into five distinct sessions comprised of:

- 1. **OPENING ADDRESSES** and introductions including an overview of meeting objectives;
- 2. A **COMMON SPACE** comprised of CSO presentations on cooperation activities with Governments and a Panel Discussion between migrant advocate organizations and Government counterparts;
- 3. THEMATIC DISCUSSION 1: Effective partnerships between countries of origin, transit and destination including presentation and working group discussion of good practices followed by a plenary summary responding to the Guiding Questions;
- 4. THEMATIC DISCUSSION 2: Good practices designed to protect migrants in an irregular situation and promote their human development including presentation and working group discussion of good practices followed by a report back and plenary summary responding to the Guiding Questions;
- 5. **CONCLUSIONS** Consisting of a meeting summary and recommendations for 2011 GFMD Concluding Debate.

Moderators will play a critical role in promoting interactive discussion among the participants following the presentations. Each presentation must take maximum 10 minutes to allow time for discussion among participants.

Appointed *rapporteurs* will help take notes of the proceedings, sum up the conclusions of the thematic discussions and the overall recommendations for the 2011 GFMD Concluding Debate. The Chair will ensure that all points of the agenda are covered, that the time allocated to speakers and to interventions from the floor is respected, and that the expected outcomes of each roundtable are achieved.


