

## Documento de Referencia Final RT 3.1

### *Empoderamiento de los migrantes, sus familias y comunidades para una mejor protección de los derechos y resultados en el desarrollo social*

#### Resultados previstos

El resultado previsto de esta Mesa Redonda es una lista de posibles medidas que deben adoptar los gobiernos de los países de origen y de residencia, a través de alianzas, por ejemplo con la sociedad civil, los actores del sector privado, las organizaciones de empleadores y de trabajadores, las organizaciones internacionales y las autoridades locales, para mejorar el acceso a los mecanismos de protección social y a los servicios sociales, entre otros la información a los migrantes en tránsito, con objeto de reducir la vulnerabilidad de los migrantes y sus familias y reducir al mínimo los costos sociales de la migración.

#### Introducción<sup>1</sup>

El empoderamiento de los migrantes se funda en los dos pilares de los derechos y las oportunidades. Un marco jurídico que proteja los derechos humanos de los migrantes y un marco político que permita a los migrantes **reclamar sus derechos y tener acceso a las oportunidades** son la base sobre la cual se pueden realizar el empoderamiento y resultados positivos en el desarrollo social. Al facilitar el acceso a los servicios básicos y a las oportunidades, los Estados reconocen el valor que los migrantes aportan a sus sociedades y la contribución que hacen a su propio desarrollo. Muy a menudo, los objetivos individuales de los migrantes incluyen elementos, como una mejor educación y salud para sus familias y comunidades que son fundamentales para el desarrollo. Cuanto mayor sea el acceso de los migrantes a los servicios sociales, y cuantas más posibilidades de elección tengan, más probabilidades habrá de que sean activos como agentes del desarrollo social y económico. Además, el acceso de los migrantes a los servicios básicos como la salud, la educación, la protección social y jurídica es una forma de garantizar que los migrantes no están excluidos de los objetivos enunciados por la comunidad internacional para la agenda de desarrollo Post-2015. Hay costos humanos, sociales y económicos si ignoramos o gestionamos mal la migración y los costos son particularmente elevados para los migrantes vulnerables, especialmente mujeres y niños, migrantes en tránsito, migrantes irregulares y explotados. Las oportunidades sin derechos pueden generar la discriminación contra los migrantes, o incluso la explotación en el lugar de trabajo y en otras interacciones tales como el alquiler de una vivienda, el acceso a los servicios públicos, y la búsqueda de una vida familiar y social normal. Los derechos sin oportunidades pueden quedarse en algo abstracto, sin desembocar en mejoras concretas en las vidas de los migrantes y las de sus familias y comunidades, lo que contribuye poco a los resultados en el desarrollo social. Por ejemplo, los migrantes pueden tener derecho a trabajar, pero si no se fomenta la diversidad en el lugar de trabajo, es posible que la oportunidad de empleo no se presente nunca. Ambos elementos de empoderamiento son esenciales.

Cuando se elabora un marco de políticas para el empoderamiento de los migrantes basado en los derechos y las oportunidades, es esencial un marco jurídico sólido, operativo y accesible a través del Estado de derecho, para proteger los derechos humanos de los migrantes, los derechos laborales y los derechos de propiedad. La conciencia de los derechos o la existencia de éstos no entrañan necesariamente la capacidad de ejercer esos derechos. Los obstáculos al acceso a los derechos y oportunidades también deben ser identificados. La manera en que se percibe a los migrantes y cómo se enmarcan en la legislación nacional es fundamental para la manera en que serán capaces de acceder a los derechos y oportunidades. Sin el acceso legal a los servicios sociales como la salud, la educación y los sistemas de seguridad social, los migrantes no dispondrán de los medios necesarios para realizar sus derechos y los resultados en el desarrollo social. Por ejemplo, el registro de nacimientos, el acceso a los documentos oficiales de identificación, etc. son los cimientos del empoderamiento de los migrantes potenciales y actuales, y pueden ayudar a eliminar las políticas migratorias basadas en el género que pueden discriminar a las mujeres o los niños o por el contrario hacer que sean más vulnerables a la explotación.

Más allá de los fundamentos en derecho, **las políticas para promover el empoderamiento de los migrantes**, sus familias y sus comunidades deben centrarse en tres grandes fuentes de **capacidad**, que pueden fomentar la facultad de los migrantes a adueñarse de sus derechos y a aprovechar las oportunidades que conduzcan a un desarrollo incluyente humano, social y económico. Estas tres fuentes de capacidad son: **la información, la voz y la conexión**.

El empoderamiento es un fenómeno complejo. Debe obrar en las dos dimensiones de los derechos y las oportunidades, a través de al menos tres fuentes de capacidad e involucrar a múltiples actores: como mínimo a los migrantes, sus familias, sus comunidades de origen y destino, las autoridades locales y nacionales, los empleadores, los sindicatos y las estructuras de la sociedad civil. Pero no todas las iniciativas requieren la participación de todos ellos a la vez. Hay un amplio abanico de programas y proyectos con éxito para el empoderamiento, que se pueden adaptar y adoptar en diferentes circunstancias en países y comunidades de origen y de destino. Algunos de estos proyectos y programas se describen en el Anexo del presente documento.

### **Información**

**El acceso a la información** es un recurso fundamental para los migrantes de muchas maneras. Les permite saber cuáles son sus derechos como migrantes, y cómo se puede proceder a la aplicación de la Ley y a la reparación en caso de violación de sus derechos. Las políticas gubernamentales pueden promover el acceso de los migrantes a estos derechos; por lo tanto, la formación y la capacitación adecuadas de los funcionarios constituyen un elemento esencial en el empoderamiento de los migrantes. ¿Han sido los funcionarios estatales formados para proteger y empoderar a los migrantes; y se han tomado medidas para supervisar la eficacia tanto de la formación como de la aplicación de políticas destinadas a empoderar y proteger a los migrantes, entre otras la lucha contra la xenofobia? ¿Hay organismos independientes a los que los migrantes puedan acudir en busca de reparación sin temor a la discriminación? ¿Se han efectuado las evaluaciones de las repercusiones para las respectivas políticas de modo a poder eliminar los obstáculos imprevistos que impiden el acceso a los servicios? Los migrantes también necesitan información sobre los canales legales de migración (y los riesgos y costos reales de la migración irregular), y sobre sus obligaciones como residentes de un determinado país. Algunos países también proporcionan información sobre cómo cambiar el estatus migratorio, por ejemplo, de temporal a permanente, de estudiante a trabajador, o de situación irregular a regular a través de un procedimiento de

regularización. Una información suministrada de forma apropiada puede familiarizar a los migrantes y sus familias con programas que pueden facilitar su integración en sus comunidades de destino y hacer que la continuación de sus vínculos con sus comunidades de origen sea más productiva. Los países de destino suelen tener amplios programas para promover la integración y la inclusión social. Por el contrario, los países de origen a menudo han establecido departamentos o ministerios dedicados a proporcionar información para su diáspora y mantener relaciones con ella. Los migrantes irregulares que vuelven a sus países de origen también necesitan una buena información acerca de las oportunidades económicas en sus países de origen, y otras opciones para la reintegración.<sup>2</sup> La información puede desempeñar una función preventiva, por ejemplo, advirtiendo a las víctimas potenciales de los peligros de la trata; o informando de los riesgos que corren a lo largo del viaje, como la travesía del mar o del desierto. La inclusión de alternativas prácticas a los viajes migratorios peligrosos en estas campañas de información mejora significativamente su eficacia.

Aquellos migrantes y miembros de sus familias que están bien informados sobre las oportunidades de educación y que tienen acceso a estas instituciones (desde las opciones de preescolar y de escuela pública a las oportunidades de becas para la educación superior), las oportunidades financieras (por ejemplo, a través de información sobre los programas de educación financiera, los productos de ahorro, los programas de inversión o los sitios web que muestran los costos del envío de remesas a través de diferentes instrumentos) o los recursos sanitarios, están mejor preparados para contribuir al desarrollo de los países de destino y de origen. Los requisitos y oportunidades difieren de un lugar a otro. Por ejemplo, ¿pueden o de hecho están obligados los migrantes a enviar a sus hijos a la escuela, incluso si están indocumentados? ¿Hasta qué edad?

¿Cómo se han puenteado los vacíos institucionales en los países de origen y destino? ¿Cómo se ha efectuado la divulgación a las comunidades de migrantes para facilitar la prestación eficaz de los servicios sociales y financieros? Por ejemplo, ¿son capaces los migrantes de abrir cuentas de pago? ¿Son los requisitos para conseguir, por ejemplo, préstamos o créditos, obstáculos para los migrantes, incluso si están bien informados? ¿Cómo se puede encontrar un equilibrio entre unas directivas de seguridad cada vez más estrictas para los servicios bancarios y los beneficios que un sistema bancario accesible puede reportar a los migrantes?

Otra pregunta se refiere a la salud: ¿a qué tipo de servicios de salud pueden acceder? A menudo existe una desconexión entre la legislación nacional y lo que sucede en la práctica. Esto se puede deber a una falta de información a los proveedores de servicios sobre los derechos de los migrantes o a una desinformación que impide a los migrantes (en particular a aquellos en situación irregular que temen ser detectados por la policía) buscar ayuda. Algunos países ofrecen atención hospitalaria y atención médica gratuitas, sin tener en cuenta la nacionalidad o el pasaporte, sino el hecho de ser residente legal durante más de seis meses.<sup>3</sup> Otros ofrecen programas de seguros para los migrantes a los que pueden contribuir financieramente, independientemente de su estatus migratorio.<sup>4</sup> Sin embargo, algunos otros ofrecen acceso a los servicios básicos de salud y de emergencia a todos los migrantes sin importar su estatus, por ejemplo, Alemania, Bélgica, España, Francia, Grecia, Hungría, Irlanda, Italia, Polonia y Suecia.<sup>5</sup>

Los empleadores, propietarios, educadores, profesionales de la salud, funcionarios públicos y otras personas que interactúan con los migrantes de forma rutinaria también necesitan una buena información sobre los derechos de los migrantes según los diferentes estatutos jurídicos, así como sobre sus obligaciones para con los migrantes –por ejemplo, los requisitos de no discriminación, razón por la cual la capacitación del personal de primera línea o de otras personas que puedan estar en contacto regular con los migrantes es una medida política necesaria y debe contar con recursos. La información también es de vital importancia para las autoridades de las jurisdicciones de destino del migrante, tanto a nivel nacional como local: ¿cuántos migrantes viven en sus jurisdicciones?, ¿qué idiomas hablan?, ¿qué competencias tienen?, ¿cuál es su perfil de edad, estado de salud, nivel educativo? Sin este tipo de información, es difícil para los gobiernos comprender las necesidades de los migrantes, el tipo de demandas que recaerán sobre los servicios públicos, o su potencial para contribuir al desarrollo de la comunidad, y por lo tanto también es difícil para los gobiernos contribuir al empoderamiento de los migrantes. Los gobiernos y las autoridades locales también necesitan información sobre cómo ayudar a aquellos que intentan acceder a sus derechos (por ejemplo, el registro de nacimiento para evitar la apatridia es un ejemplo) a obtener la ayuda que necesitan. La divulgación de la información debe ir acompañada de políticas y procedimientos que ayuden a los migrantes, una vez dispongan de la información, a acceder a los servicios proporcionados por el gobierno sin temor al rechazo, la discriminación o la recriminación de los funcionarios públicos.

Los gobiernos de los países y comunidades de origen de los migrantes también dependen de una información precisa para localizar a sus ciudadanos en el extranjero, a quien deben protección consular y por lo menos algunos de los servicios mínimos, como el suministro de documentos y el registro de nacimientos, defunciones y matrimonios.

Estos gobiernos tienen interés en conocer la ubicación y características de las poblaciones de la diáspora (emigrantes y sus descendientes) si esperan contar con la ayuda de la diáspora para el desarrollo nacional. En algunos casos, los gobiernos desarrollan buenas relaciones con la diáspora mediante la ejecución de programas de información para promover el bienestar de la comunidad migrante, como las "Ventanillas de Salud"<sup>6</sup> puestas en marcha por los consulados mexicanos en los Estados Unidos para proporcionar información sobre temas de salud, asesoramiento y la referencia a servicios de salud accesibles a los migrantes y sus familias.

Los migrantes, especialmente los migrantes hacia los países desarrollados, viven en un contexto de exceso de información. Muchos migrantes dependen en gran medida de su propia comunidad como fuente y filtro de la información. Las redes de pares constituyen unos divulgadores muy eficientes, pero no siempre tienen acceso a información correcta u oportuna. Las alianzas entre organizaciones de migrantes y líderes comunitarios, gobiernos locales y nacionales, empresas del sector privado, asociaciones de empleadores y sindicatos, y organizaciones de la sociedad civil tienen un gran potencial para casar el suministro de información fiable con la creación de redes eficaces de manera a ofrecer a los migrantes una información empoderadora. Es muy importante asegurarse de que se les facilite esa información en idiomas que los migrantes entiendan, o que estén disponibles servicios de traducción. En algunos Estados, existen programas que apoyan la labor de divulgación de los sindicatos para empoderar a los trabajadores migrantes, ofreciéndoles mejores servicios e información.

## Voz

**Una voz pública eficaz** es a la vez un vehículo y una señal de empoderamiento de los migrantes. Les permite hablar en defensa de sus derechos, abogar por sus necesidades, y expresar sus contribuciones reales y potenciales a sus países y comunidades de origen y destino. Las voces de los migrantes pueden ser más eficaces en combinación con las voces de otros defensores de los derechos humanos y de la igualdad de oportunidades. Por ejemplo, el movimiento liderado por los trabajadores domésticos migrantes que llevó a la aprobación del Convenio de la OIT sobre las trabajadoras y los trabajadores domésticos N° 189<sup>7</sup> recibió el apoyo aliado de organizaciones de derechos humanos, sindicatos y otros activistas de ambos países de origen y destino.

Una voz pública también puede contribuir a disminuir las actitudes racistas y xenófobas en los países de destino: el miedo a lo desconocido contribuye a este tipo de actitudes, y fomentar las voces de los migrantes en diferentes esferas públicas y privadas puede aumentar la familiarización con las culturas y las experiencias de los migrantes. Debe reconocerse, sin embargo, que las voces de los migrantes –incluso aquellos que vienen de un mismo país– son diversas. Nadie debe esperarse a que emerja un solo mensaje o voz.

Los migrantes tienen experiencias diferentes en función de su nivel de competencias y estatus jurídico. **Los migrantes altamente cualificados** contratados en el ámbito de su red de contactos profesionales se mueven fácilmente a través de las fronteras, conservando normalmente unos derechos sociales y económicos completos y en muchos casos la portabilidad de las pensiones. Por otro lado, los **migrantes poco cualificados** tienen más probabilidades de terminar en **situaciones irregulares** en ausencia de canales adecuados de migración regular, como situaciones de trata o de explotación –y el **riesgo es mayor para las mujeres y los niños**. También es menos probable que sean capaces de defenderse por sí mismos. ¿Pueden **los niños participar de manera significativa** en las decisiones que afectan a ellos o a sus padres?, ¿tienen derecho a ser escuchados en los procedimientos relativos a la admisión, residencia y expulsión de sus padres y pueden apelar la deportación de sus padres para garantizar que todas las decisiones se toman en su mejor interés?<sup>8</sup> ¿Cómo pueden los actores estatales y de la sociedad civil colaborar para garantizar que todos los migrantes, incluidos los migrantes irregulares, tengan una voz?

Si bien la voz de una sola persona puede ser potente, es probable que la expresión más eficaz de las aspiraciones, las necesidades y los talentos de los migrantes surja a través del empoderamiento de los grupos comunitarios y su participación en la vida cívica. Deben asegurarse de que se invita a un amplio abanico de portavoces de las comunidades de migrantes (que representen a toda la comunidad, incluyendo a las mujeres, los jóvenes y todo el espectro de grupos sociales) a participar en el debate público sobre las cuestiones que les conciernen o que conciernen a las comunidades de las que forman parte. De esta manera, las autoridades no sólo empoderan a los migrantes, sino que demuestran que los migrantes son reconocidos como actores de la comunidad en general. Un ejemplo de esto son los *Consejos de Integración de los Migrantes* de Grecia que promueven la participación activa de los migrantes en la toma de decisiones locales.<sup>9</sup> Estos consejos, que tienen una función consultiva en cuestiones relativas a la integración de migrantes en las comunidades locales, promueven

la participación activa de los migrantes en la toma de decisiones a nivel local y contribuyen de manera significativa a la promoción de la integración de los migrantes y al fortalecimiento de la cohesión social. La sociedad civil también tiene un papel que desempeñar en la inclusión de los migrantes en el amplio espectro de la participación cívica.

Un elemento importante en la promoción de las voces de los migrantes es la oportunidad para los migrantes de compartir sus culturas con la comunidad en general. Tanto las autoridades de los países de destino como las organizaciones de la sociedad civil pueden apoyar la labor de museos o exposiciones, espacios para las artes escénicas y centros culturales que permiten la expresión de la herencia de los migrantes y proporcionan un foro para que puedan contar sus historias –y la gran historia– al público en general para que tenga una mejor apreciación del papel que la migración ha desempeñado en el desarrollo socioeconómico. En muchos casos, los gobiernos de los países de origen juegan un papel importante a la hora de respaldar y dar a conocer la cultura de los países de origen. Los gobiernos de los países de origen de los migrantes también han dado a las comunidades de migrantes, en muchos casos, una voz en los asuntos públicos que les afectan mediante el establecimiento de consejos consultivos compuestos por representantes de migrantes. Algunos gobiernos incluyen representantes de los migrantes en la legislatura nacional. Una de las acciones más definitivas que dan una voz política es permitir votar a los nacionales que viven en el extranjero. Algunos Estados también permiten la doble nacionalidad. Expresar su voz puede no venir de forma natural a los migrantes, sobre todo para aquellos que han dejado un contexto en el que se desalienta o incluso castiga el debate público, en un lugar donde se espera que los grupos de interés de diversa índole se inserten en la competición de ideas y demandas. Como resultado de las convenciones culturales, puede constituir un verdadero desafío convencer a las mujeres y a los jóvenes para que entren en el debate público. Al abordar este desafío, las organizaciones de la sociedad civil, del interior de la comunidad migrante y de fuera de ella, tienen un papel importante que desempeñar, especialmente en el tratamiento de las cuestiones culturales sensibles o al desafiar las normas de género.

Un creciente número de migrantes son menores no acompañados o menores separados de sus familias. Sin una voz que abogue por la provisión del restablecimiento de los vínculos familiares o de disposiciones apropiadas para su guarda, corren un alto riesgo de abuso y explotación. Sus derechos pueden ser violados durante el recorrido migratorio, y sus perspectivas de un futuro seguro y productivo son a menudo tenues sin el apoyo directo de las autoridades nacionales y los actores de la sociedad civil.

Los programas de educación para los migrantes, en particular los cursos de alfabetización e idioma son elementos esenciales para el empoderamiento de las voces de los migrantes. Muchos también ofrecen un acceso a la educación superior en las mismas condiciones y requisitos que los oriundos del país. Un requisito previo para el ejercicio de la voz es la capacidad de comunicarse con los demás en un idioma común. La inversión en el aprendizaje del idioma del país de destino es productiva, tanto para los migrantes como para las sociedades a las que llegan, y debe ser una prioridad en los marcos de políticas de empoderamiento. Algunos Estados permiten el libre acceso al aprendizaje de idiomas, otros lo ofrecen por un módico precio. Muchas autoridades locales en los países de destino ofrecen la enseñanza de idiomas para facilitar la entrada de los migrantes en el mercado laboral y para trabajar en profesiones que se ajusten a su formación educativa.<sup>10</sup> Ser capaz de expresar sus preocupaciones en una lengua común es un primer paso para los migrantes que deseen

participar en los sindicatos o defender los derechos laborales. Algunos Estados de destino también ofrecen un soporte gratis para el aprendizaje de idiomas para asegurar que los niños migrantes conservan y desarrollan su lengua materna, al tiempo que aprenden la lengua del país de acogida.

## Conexión

**Los migrantes generalmente actúan como un puente que conecta** sus países de origen y de destino, pero a menudo es difícil para ellos mantener los lazos con los familiares y las comunidades que han dejado atrás. Aunque la separación de la familia y de los amigos puede ser, a juicio del migrante, la mejor opción entre un número limitado de opciones, los responsables políticos pueden obrar para ampliar esas opciones mediante la apertura de vías para la reagrupación familiar en ciertas circunstancias, por ejemplo, en el caso en que los migrantes están bien establecidos y son capaces de mantener a sus familias; para los estudiantes de doctorado o para los migrantes en determinadas categorías de competencias, cuando sus cónyuges también pueden cualificarse para un permiso de trabajo. ¿Cómo se pueden eliminar las barreras a la integración social y económica? ¿Cómo pueden los países de destino facilitar la entrada al mercado laboral o el acceso al crédito financiero a los migrantes? Mediante la recopilación de datos sobre lo que funciona, mediante la búsqueda de formas de reducir los costos sociales de la migración, los países pueden respaldar el empoderamiento de sus ciudadanos en el propio país y como migrantes.

Las remesas enviadas por los migrantes a los países de origen que a menudo promueven el acceso a la salud y educación para los miembros de la familia que se han quedado atrás ofrecen un ejemplo concreto de cómo el hecho de mantener conexiones entre un migrante y su país de origen tiene un impacto directo sobre el desarrollo socioeconómico de una determinada unidad familiar o comunidad.<sup>11</sup> Para muchos, las remesas han permitido a los miembros de la familia acceder a oportunidades de desarrollo socioeconómico a largo plazo,<sup>12</sup> sin olvidar que se debe prestar especial atención a los niños que se quedan en el país. Hay implicaciones psicosociales para un niño que puede sentirse abandonado, con la posibilidad de que afecten a los resultados educativos.<sup>13</sup> Al mismo tiempo, según la situación socioeconómica de la familia, tener padres que son migrantes laborales pueden empoderar a los niños en las escuelas públicas, pero la misma situación puede estigmatizarlos en las escuelas privadas. ¿Cómo han colaborado los responsables políticos en los países de origen con las comunidades locales para reducir el estigma sobre los miembros de la familia y los niños que se han quedado u otros costos sociales de la migración?

Las remesas financieras son de hecho una forma de protección social ya que diversifica los riesgos y mejora los medios de vida. Sin embargo las discrepancias en los requisitos de los documentos de identidad para los sectores de servicios bancarios/financieros en los países de origen y destino pueden excluir a muchos migrantes de la utilización de los canales formales. Algunos Estados de origen han negociado con los Estados de acogida para que sean reconocidas las tarjetas de identidad con elementos de alta seguridad, con objeto de facilitar el acceso de los migrantes a los servicios, incluida la banca, independientemente de su estatus

migratorio.<sup>14</sup> La migración circular, facilitada por múltiples visados de reingreso y requisitos de residencia flexibles en el camino hacia la residencia permanente, podría hacer más fácil para las familias migrantes mantener sus conexiones a través de las fronteras. Los gobiernos de los países de origen y de destino deben hacer que las telecomunicaciones sean todo lo baratas y fáciles que permita la tecnología actual. Las iniciativas que empoderan a los migrantes para que dirijan sus remesas hacia fines particulares, tales como gastos de escolaridad, hipotecas o seguros médicos, han dado buenos resultados y podrían ser ampliamente replicadas. El sector privado (bancos) puede desempeñar un papel importante al proporcionar "paquetes" de servicios inteligentes diseñados especialmente para los migrantes y las comunidades de la diáspora.

Los Estados y las autoridades subnacionales en los países de destino pueden fomentar el empoderamiento de los migrantes mediante la creación de estructuras para conectar los migrantes al gobierno a todos los niveles. En los países de destino, una "Oficina de Nuevos Residentes" nacional, así como oficinas similares en el ámbito local pueden colaborar con organizaciones de la sociedad civil para facilitar el acceso de los migrantes a los servicios que están disponibles para ellos (que probablemente son diferentes para los residentes permanentes, los migrantes temporales y los migrantes irregulares), para informarles de sus derechos, darles a conocer las oportunidades y aumentar el conocimiento mutuo entre los migrantes de diferentes orígenes y la población nativa.

El empoderamiento está estrechamente vinculado a la vida asociativa de los migrantes, y a su capacidad para organizarse. Las Asociaciones de las Comunidades de Origen (HTA por sus siglas en inglés), asociaciones de alumnos, asociaciones profesionales y otros tipos de organizaciones de migrantes, junto con los medios de comunicación social (Skype, Facebook, etc.) conectan a los migrantes en los países de destino a sus comunidades de origen, en un contexto de toma de decisiones conjuntas sobre las necesidades y prioridades de la comunidad de origen. En algunos casos, los gobiernos de los países de origen han colaborado con estas organizaciones para ampliar y reproducir sus actividades.

¿Cómo pueden los Estados empoderar a los migrantes que se hallan en ellos, y cómo pueden los países de origen contribuir a empoderar a sus emigrantes y grupos de la diáspora? ¿Qué alianzas son susceptibles de hacer todo lo posible para promover esta agenda y apoyar acciones constructivas por parte de los migrantes y los grupos de la diáspora? Muchas estructuras regionales e internacionales, entre ellas principalmente el *Foro Mundial sobre Migración y Desarrollo*, han creado oportunidades para que los países aprendan de las experiencias de los demás, y compartan información.

Las conexiones entre los migrantes, las diásporas, sus comunidades y sus países de origen están demostrando que la "comunidad transnacional" no es sólo un término académico, sino una realidad viva. Estas comunidades no sólo envían remesas económicas y sociales a través de las fronteras, sino que ayudan a romper el aislamiento de los países en desarrollo de las redes globales de conocimiento, comercio, tecnología e inversión. Este aislamiento es una causa, y una de las consecuencias más perjudiciales, de la falta de desarrollo. En algunos países, el Estado y/o las autoridades locales están trabajando para promover conexiones entre los países de origen y de destino a través del hermanamiento o del retorno de profesionales cualificados.

El poder de las conexiones puramente personales no debe subestimarse, sobre todo su poder para disminuir las actitudes racistas y xenófobas. Las encuestas de opinión muestran sistemáticamente que las personas que expresan opiniones vehementes contra la migración o contra los migrantes tendrán, no obstante, un parecer muy positivo acerca de migrantes que conocen personalmente. Las implicaciones políticas de estos hallazgos son que hay que oponerse enérgicamente a la segregación residencial y educativa, y que debe promoverse la interacción entre los migrantes y los oriundos del país, en particular a través de elementos de la vida cotidiana como la música, el deporte, la alimentación y la educación, que pueden quebrantar la "otredad" del migrante.

## Conclusión

**El empoderamiento abarca la capacidad de tomar decisiones informadas y significativas** acerca de su propia vida (incluyendo la opción de migrar). Se basa en la protección y promoción de los derechos humanos, y depende de que se abran oportunidades a través de las cuales los migrantes pueden seguir luchando por sus objetivos como individuos y como miembros de familias y comunidades múltiples. Muy a menudo, los objetivos individuales de los migrantes incluyen mejor educación y salud para sus familias y comunidades que son fundamentales para el desarrollo. Cuanto mayor sea el acceso de los migrantes a sus derechos, y cuantas más posibilidades de elección tengan, más probabilidades habrá de que sean activos como agentes del desarrollo social y económico. Como resultado de las conexiones transnacionales de los migrantes, se está poniendo de relieve un círculo virtuoso *–los migrantes empoderados empoderan a los demás*. Cuando los migrantes pueden ejercer sus derechos y aprovechar las oportunidades, comparten activos, crean asociaciones, transfieren sus conocimientos y competencias a sus países de origen, y ofrecen innumerables ejemplos de acciones positivas. La dinámica de estas interacciones, a través del acceso a la información, la voz y la conexión, está cada vez mejor comprendida. El desafío político ahora es avanzar firmemente hacia la aplicación de medidas prácticas de empoderamiento, basadas en los dos pilares de los derechos y las oportunidades.

## Vínculos a otras Mesas Redondas del FMMD

El tema del empoderamiento está implícito en todas las mesas, pero la **RT 3.1 explora herramientas que mejoran el empoderamiento de los migrantes**. Dentro del marco de un Estado de derecho que salvaguarde los derechos de los migrantes, los Estados pueden desarrollar políticas que promuevan el empoderamiento activo de los migrantes. El acceso de los migrantes a la información, su capacidad para abogar por sí mismos y su oportunidad de actuar permitirán su contribución al desarrollo. Al centrarse en diferentes dimensiones del empoderamiento, esta mesa redonda identifica métodos y prácticas que pueden alimentar los debates de política abordados en otras mesas redondas, como la Agenda de Desarrollo Post-2015 de las Naciones Unidas, el espíritu empresarial de la diáspora y la adecuación de las competencias. Como la contratación es un punto de la RT 2.1 *Optimar los efectos de la migración laboral y la movilidad circular en el desarrollo a través de un mercado laboral sistemático más importante y una mayor adecuación de competencias*, habrá cierto grado de solapamiento con la RT 3.1. Sin embargo, la RT 3.1 no se centra en la adecuación de las competencias o en la participación en el mercado laboral, sino en la dimensión social de la migración, tomando en cuenta el género, la edad y las competencias de la persona en cuestión. La RT 3.1 trata de manera amplia sobre cómo el empoderamiento contribuye a la actuación de los migrantes como individuos, miembros de familia y miembros contribuyentes de la sociedad, mientras que en la RT 3.2, la discusión se centra en cómo los migrantes, como actores del desarrollo, pueden contribuir a unos resultados positivos para el desarrollo, específicamente en los ámbitos de la salud y la educación en los países de origen.

### **Preguntas de Orientación para la RT 3.1**

- a) ¿Cómo han ampliado los gobiernos y demás partes interesadas pertinentes los servicios sociales, incluida la salud y la educación, a los migrantes?
- b) ¿Cuáles son las barreras que impiden a los migrantes, especialmente las mujeres y los niños, acceder a la información que necesitan en relación con sus derechos? ¿Cómo pueden los Estados, la sociedad civil y otras partes interesadas colaborar de manera a asegurar que los migrantes tengan la información que necesitan y el acceso a las oportunidades ofrecidas?
- c) ¿Cómo pueden recibir apoyo los migrantes para tener una voz en las cuestiones que afectan a su bienestar social y económico? ¿Qué marcos normativos y jurídicos son necesarios para garantizar que los migrantes (incluidos los niños) tengan la capacidad de defenderse a sí mismos y a los miembros de su comunidad? ¿Cómo han colaborado los Estados con las asociaciones de migrantes y/u otros actores para abordar el tema de la percepción pública de los migrantes?
- d) ¿Cómo pueden las conexiones entre los miembros de una familia y entre el país de origen y de destino ser reconocidas y mejoradas? ¿Cómo pueden los Estados reducir al mínimo el costo social de la migración laboral (familias dejadas atrás), teniendo en cuenta las necesidades de protección y empoderamiento de los migrantes independientemente de la edad, género, competencias/nivel de ingresos o estatus migratorio?

The study focused on young people ages 15 to 24 who were potential migrants or migrant returnees. A similar project was implemented in 2013, in Athens, Piraeus and Thessaloniki. About 5.000 migrants made use of the services offered in these offices, while 2.500 leaflets in the above mentioned languages were distributed.

An assessment of the initiative revealed that it enhances participants' responsibility towards savings, increases gender sensitivity and their entrepreneurial disposition, as well as their interest in education. The Department of Education included Atikha's modules in the school curriculum in three regions with large populations of children and families left behind, and the good results shown by preliminary evaluations and informal assessments suggest that the initiative will eventually be scaled up.</p>

To further strengthen channels of communication between DOL and the public, WHD contracted with an interpreter service line with a capacity of more than 170 languages via a toll free telephone number. WHD also offers in-person interpretation services for special circumstances. To achieve a more ongoing presence in communities with at-risk workers, the Division has hired new Community Outreach and Resource Planning Specialists to work in several WHD District Offices. WHD also released a series of educational "Know Your Rights" videos to inform workers of their rights and to provide information on how to file a complaint with WHD. Shoe cards containing the 24-hour hotline to the National Human Trafficking Resource Center (NHTRC) are distributed through grassroots methods via victim service providers and faith-based organizations. These tear cards are available in English, Spanish, Chinese, Russian, French, Korean, Thai, Vietnamese, and Indonesian – with shoe cards also currently available in English, Spanish and Korean.

<p><b>Summary:</b> In Vietnam, Migrant Worker Resource Centres (MRCs) have been established in the employment service centres run by the provincial department of labour since 2011. This model of an integrated service offers ample opportunity for scale and sustainability. It is estimated that 20% of job seekers that visit the employment service centers are interested in working outside of the country. In addition to the typical drop-in and outreach service, this model also allows for potential migrants to be reached through job fairs. Counseling is provided through outreach activities, online and over the phone. Information is also disseminated through broadcasts on local radio and television, and through seminars on safe migration in schools and vocational training centres.</p> <p>The MRCs are implemented in collaboration with the Department of Labour in five provinces in Vietnam. The ILO provides technical and financial support to the MRCs through the GMS TRIANGLE project.</p>	

The project has organized training for provincial authorities and staff of the MRCs on the relevant laws related to the sending of workers abroad, and on the delivery of support services. The project has also developed an MRC Operations Manual, a communications plan and other resources, to provide more guidance to staff of the MRCs in the running the centres, and reporting the achievements. Through monitoring missions, the project and the Department of Overseas Labour provide additional coaching to staff of the local department and MRC staff.

**Tags:** Protection, empowerment and rights of migrants

**Summary:**

This unique initiative has documented and analysed the many forms taken by the mobility of children and young people in West and Central Africa, based on the key tenet that mobility of children goes both with risks and vulnerabilities as well as opportunities and personal development. Movement per se does not increase the vulnerability of children and youths, it is the conditions under which they move that do so. Movement has negative impacts when children lack protection. The concept of ‘protective accompaniment of children’ has emerged as a key tool in this context, with the following key elements: unaccompanied migrant children should be seen not only as victims, but also as agents in their own rights; fulfilling their right to human development should be seen as integral part of their protection; and both families and communities need to be more involved in the protection of these children in order to enhance the continuity of the protective environment.

<p><b>Summary:</b>            The Australian Government’s Adult Migrant English Program (AMEP) provides eligible new migrants and humanitarian entrants with up to 510 hours of free English language tuition to assist with their settlement in Australia.            Humanitarian entrants with limited prior education or difficult pre-migration experiences, such as torture or trauma, are also able to access additional English language tuition under the AMEP’s Special Preparatory Program.            Some individuals are also able to participate in the AMEP Settlement Language Pathways to Employment and Training program which helps migrants to learn English while gaining familiarity with Australian workplace language, culture and practices.            The AMEP is delivered at over 250 locations across Australia, as well as via distance and online learning.            Students with children under school age are able to access free childcare services, to facilitate their attendance at AMEP classes.            Specialist AMEP counsellors help to guide and support students during their time in the program.</p>

<p><b>Summary:</b></p> <p>The Seasonal Worker Program aims to contribute to Pacific islands' and Timor-Leste's economic development objectives while assisting Australian employers who cannot source local labour. Citizens of Kiribati, Nauru, Papua New Guinea, Samoa, Solomon Islands, Timor Leste, Tonga, Tuvalu and Vanuatu are able to participate in the programme.</p> <p>The Department of Employment is the lead Australian agency and responsible for the implementation and management of the programme. The Department of Immigration and Border Protection supports the programme by managing the visa application process, ensuring visa compliance is monitored and by providing assistance with training participating countries on Australia's visa requirements.</p> <p>The programme is available to the horticulture sector and, on a trial basis, the accommodation, aquaculture, cane and cotton sectors in selected regions. It is a demand driven programme and take up is dependent on Australian employers' demonstrated demand for labour, employer choice to use the programme and employer choice as to which country they recruit from. Employers wishing to participate in the programme need to become approved sponsors and are subject to sponsor obligations under the <i>Migration Act 1958</i>, which provides robust worker protection to seasonal workers similar to those in other temporary work visa programmes.</p> <p>Seasonal workers can be employed from 14 weeks to six months, with a maximum stay of seven months in Australia in any 12 month period, and may return for following seasons.</p> <p>The programme promotes opportunities for employment to facilitate inclusive participation, including through the active promotion of participation by women and underrepresented groups. Seasonal workers are involved with local communities in Australia through participation in cultural, religious, sporting and other events.</p> <p>Developing skills is an important feature of the Seasonal Worker Program. The "Add-on Skills Training" component of the Seasonal Worker Program allows seasonal workers to access basic training opportunities to increase their performance capability both in Australia and in their home country. Seasonal workers have an opportunity to receive formal qualifications under the Australian Quality Training Framework at no cost to seasonal workers or their employers.</p> <p>The Seasonal Worker Program provides economic assistance to partner countries by increasing welfare to households and communities through remittances. By participating in the programme, workers can provide support to their family and community, assisting with educational development and long-term job creation.</p>

The second campaign concerned the same topics as well as information on practical everyday issues, and the value of interculturalism. Thirty thousand (30.000) leaflets in English, Russian and Arabic have been distributed for each of the above fields.</p>

They enjoy the same rights as nationals concerning social security and social protection. Migrant minors are subject to obligatory school attendance as nationals and they enjoy free access to all activities within the educational communities at all levels of education. Migrant children who have graduated from secondary education in Greece they have access to Universities and Technical Schools under the same conditions and prerequisites as nationals.

The celebration of Migrant's day included thematic film showing, painting workshops for migrant children, music, workshops, puppet shows, interactive games for Greek and migrant children, concerts, traditional dances, a Christmas bazaar and a performance with the participation of children.</li> <li>- The third one took place on 18/12/2011 (Migrants Day) in Athens, Thessaloniki and the city of Volos. Performances, showing of thematic films and documentaries on migration, interactive games for the children, concerts, traditional dances, ethnic cuisine were the main activities of this festival for Migrants day.</li> <li>- Three more festivals have been organized: one in Thessaloniki where thematic films and documentaries were shown, a second one in the city of Alexandroupoli where such events as painting, sculpture and theatre took place and the last one in the city of Kozani where a photo festival took place. About 300 people visited each one of these festivals.</li> <li>- A festival of Cultures in the cities of Athens, Herakleion (Krete) and Thessaloniki took place from May 2013 to June 2013. In the context of these festivals the following activities took place: a theatre performance named "Ekavi project" which was an innovative approach to the ancient tragedy "Ekavi" with the participation of Greek and migrant actors, music concerts, exhibitions of painting and photography.</li> </ul>

Overall 245 young people participated.</p>

<p><b>Summary:</b>  In the framework of the European Union Directive for family reunification and in order to facilitate spouses' smooth integration in the Greek society, two projects targeted to family members took place. The first project took place in Athens and was entitled “Mum is learning Greek”. It comprised of Greek language and history courses addressed to migrant mothers. Overall 400 migrant mothers attended it, while their children were kept busy by skilled personnel. The second project took place all over the country (Athens, Piraeus, Patra, Volos, Larissa, Lamia, Kalamata, Herakleion, Chania, Rhodes, Kos, Symi, etc) and was addressed to illiterate migrant parents. Each course consisted of 14 thematic units and lasted 150 hours. Overall, 500 people attended it.</p>

<p><b>Summary:</b>  Specifically: a) a two day event which took place in Athens and included: a structured dialogue on “migration and the economic crisis”, a dance performance, a concert with Greek and migrant musicians, a painting exhibition, a workshop for children, a photo exhibition, multicultural food cooking, the showing of documentaries, etc., b) a Cultural Festival in Thessaloniki (19-20 June 2012) where music and dancing performances were organised, as well as a workshop on “interculturalism and the basic principles of intercultural mediation and crisis management”, c) a Cultural Festival in Alexandroupoli (23-24 June 2012), where the following activities took place: a theatre performance, an interactive and intercultural game for children and a workshop entitled “the intercultural dialogue as a means for migrant integration at the local level”, c) information and cultural activities in the cities of Chania (island of Crete) and Mytilini (island of Lesbos). The activities included: workshops on the role of Migrants' Integration Local Councils in resolving problems at the local level, educational games for primary school students, educational games for adolescents, workshops for migrants' access to social services. It is estimated that 1.000 people attended these events in both cities. Similar events took place in the cities of Volos and Ioannina. In Volos, a football and a cricket tournament between Greek and migrant teams and an eight kilometer race took place in 2010.</p>

The campaigns included interactive seminars, showing of short films, thematic workshops, cultural events and the setting up of a volunteer network. In addition, a glossary on civil rights, education and other issues was developed and distributed.</p>

<p><b>Summary:</b>  <b>Activities for migrants and locals at the neighborhood level</b> took place in Athens and Thessaloniki. Overall about 2.000 people took part in these activities. The activities included: workshops on garbage composting, bicycle repair courses, workshops on old clothes remaking, workshops on handicrafts making, oral history workshops, a workshop entitled “neighborhood radio” where participants played the role of the “broadcaster of the neighborhood” in the local radio station of Athens, athletic events, dance and music performances.</p>

<p><b>Summary:</b>  Greek local government structures were re-organised in 2010 through the Programme “Kallikratis”. As a result, an important part of the everyday implementation of migration and integration policy was transferred to the newly-formed Decentralised Administration structures. In the field of integration policy, Programme “Kallikratis”, introduced the setting up of <b>Migrant Integration Councils</b> (MICs) in the 325 Municipalities of the country. Migrant Integration Councils are entrusted with a consultative role on issues pertaining to migrant integration in local communities. Specifically, the role of Migrant Integration Councils is to identify integration problems faced by TCNs legally residing in the Municipalities and submit recommendations and proposals to the municipal councils concerning the development of local actions for the smooth integration of TCNs in local societies. Taking into account that the members of Migrant Integration Councils include not only municipal councillors but also representatives from the local immigrants’ communities, it is evident that the Migrant Integration Councils ensure interaction between host society and TCNs and encourage immediate local participation of all residents. Since the latest local government elections in 2010 and until July 2013, 220 MIC’s had been set up, some of which are more active than others.</p> <p>The European Integration Fund has funded the following actions for the support of Migrant Integration Councils: two actions on the technical support of Migrant Integration Councils, a training program for MIC members regarding the operation of the Councils and the networking between MIC members, and an action concerning the development of a cooperation network among member states at the local level.</p>

<p><b>Summary:</b>  The association mobilized mothers who have suffered a loss to speak about the dangers of irregular migration. The mother-son relationship has always been at the heart of the migration process in West Africa, and the recent change in the mothers’ attitudes has been a key component of the campaign against irregular migration to Europe. In addition, the income-generating and micro-finance projects have allowed some young potential migrants to stay in Senegal or to gather the financial means to travel through legal channels</p>

<b>Title: Swedish Language Training for Professionals (SFX)</b>

<p><b>Summary:</b>  This language training programme improves the possibilities of migrants to enter the labour market and to work in profession that fit their educational background. In many parts of Sweden, language courses, or so called SFX educations – “Swedish for professionals” are organised at municipality level aiming at migrants with different professional backgrounds. The teaching of the Swedish language focuses on the development of the professional language. The training also provides the opportunity to learn how the job market is functioning and how one’s own profession is exercised in Sweden. If possible, internships are included in the programme and add-on trainings in college or high school may be provided. The overall aim of sfx is to shorten the time to get a job or to build up one’s own company.</p> <p>Examples of sfx training are Swedish for bus drivers, business owners, craftsmen, engineers, truck drivers, medical professionals, staff and IT specialists, and others. The sfx-courses are free of charge for participants and paid by the home municipality. Due to a recent report from Stockholm municipality 48% of those that participated in sfx are working in their profession, 19% in another area and 13% are studying at university or in adult.</p>

<p><b>Summary:</b> In order to improve and encourage integration of regular migrants, the Swiss confederation together with the Swiss cantons implemented a common strategy for integration. The main objectives are the reinforcement of social cohesion, the encouragement of mutual respect and tolerance, and the participation of foreigners in the Swiss society. The strategy is based on three pillars 1) Information and counselling; 1) Education and employment; 3) Mutual understanding and social integration. For each of these pillars, the confederation and the cantons have identified 8 key areas where measures were needed to reinforce integration: such as for instance a comprehensive information scheme for migrants recently arrived in Switzerland, measures to improve language skills, access to school and training, intercultural interpreting, integration in the labour market among others. For each of these areas, the Confederation and the Cantons have agreed upon binding strategic objectives. On this common strategic vision, each Canton has elaborated a cantonal integration program (CIP) for the period 2014-2017 in which all specific integration support measures are bundled together. The programmes are jointly financed by the Confederation and the Cantons. In the strategy the Confederation and the Cantons recognize that the protection against discrimination is an essential condition for the integration of migrants in Switzerland and specific measures such as counselling of migrants and relevant institutions will be implemented.</p>

Migration was not included in the MDGs, however, the second High-Level Dialogue on Migration and Development, which took place at the United Nations in New York on 3-4 October 2013, reached consensus on the need to consider how to include migration in the post-2015 development agenda.</p> <p>In support of this, the online discussion provided an open, public forum to look at the impact of migration on adolescents and youth, (individuals aged 10-24, according to United Nations definitions), and how to reduce the negative impacts and increase the positive benefits for adolescents and youth and countries of origin and destination alike, within the framework of the post-2015 development agenda. The discussion was developed and led jointly by Civil Society and UN partners.</p> <p>The discussion took place on the World We Want 2015 Website, which has hosted a series of joint UN- Civil Society “Global Thematic Consultations on the Post-2015 Development Agenda”<sup>2</sup> led by UNDG, including a year-long series of discussions on addressing inequalities in the post-2015 development agenda, led by UNICEF and UN Women<sup>3</sup>. This online discussion continues the series, and while migration was included in the Thematic Consultation on Population Dynamics, this discussion provided an opportunity to focus on the impact of migration on adolescents and youth, issues not extensively discussed in the Global Consultations.</p> <p><b>Some Key Recommendations for the Post-2015 Development Agenda:</b></p> <ol style="list-style-type: none"> <li>1. Enable migrant adolescents and youth, including the children of migrants, to <b>access social protection services</b> in countries of destination.</li> <li>2. Strengthen social safety nets to ensure school attendance, health care and other basic services for <b>children whose parents have migrated</b>.</li> <li>3. Strengthen efforts to combat xenophobia, racism and <b>discrimination</b> towards migrants and children whose parents have migrated.</li> <li>4. Create safe environments for adolescents and youth affected by migration, including the most vulnerable, to enable their <b>active participation in policy processes</b> and ensure their views and experiences are considered when formulating the post-2015 development agenda.</li> <li>5. **Summary:**

These reports present the situation of the Roma and related groups – such as Ashkali and Egyptians in Kosovo, Sinti, Kale and Travelers. According to these reports, these groups remain among the most marginalized populations in Europe. They tend to suffer from widespread discrimination and systematic social exclusion. Although the pattern of social exclusion is part of a historic legacy, living conditions of many Roma in Central and Eastern Europe have worsened over the last two decades. Economic transformation resulted in the disappearance of many low-skilled jobs. Across the region, gaps between the Roma and majority populations, in terms of employment, quality of housing, educational achievement and health status, have grown dramatically.

The reports have had some positive policy impacts. For instance, the governments of North Rhine Westphalia, Saxony-Anhalt and Bremen issued decrees taking into account the length of stay in Germany and the child's level of integration and schooling in decisions on residence titles. The decree issued in September 2010 by the minister of the interior of North Rhine Westphalia was of particular significance, as it explicitly instructed authorities to take the best interest of the child into primary consideration. This has been a core recommendation of UNICEF in last year's report.

Another positive step in the right direction are the recent amendments to the Aufenthaltsgesetz passed by the Federal Parliament, making the extension of residence titles possible on the ground of a child's good integration and school record.

Relevant decisions have also been made in Kosovo. The government established a Reintegration Fund in the past year, which earmarked 3.4 million Euros for reintegration assistance.

<p><b>Summary:</b></p> <p>The objective of this card is to provide Mexican migrant workers in the United States with a document that can act as an identify card, thus facilitating access to services. An additional objective is to streamline assistance and lower remittance transfer costs. Since 1871 Mexican embassies and consulates in a have issued identification documents (matrícula consular) to their nationals abroad. In the United States, high security features were then added to these documents in 2002 in response to the US government's security concerns after September 11. Fifty Mexican consulates operate in the United States and provide documentation, legal and social assistance, and cultural services. Consulates also coordinate with local organizations, Mexican associations, and state and national authorities to educate Mexican immigrants on a range of issues, including safety and health in the workplace. The matrícula consular is an identify card, with a photograph and other security features, that attests that the bearer of the card is a national of Mexico living abroad. The card costs about US\$ 29 and is valid for five years. In May 2003, the Treasury Department established regulations recognizing the cards as proof of identity for the purpose of opening a bank account. The cards are accepted for other community services as well, such as signing up for. It has been particularly useful for undocumented Mexican migrants in that it provides them with identification documents. In 2005, 118 banks in the United States accepted the matrícula consular as an alternative form of identification to open bank accounts. Increased access to banks has the additional benefit of reducing transfer costs of remittances to Mexico.</p>

<b>Summary:</b> The SECO Start-up fund was opened in 1997 as a credit facility (i.e. loans are to be repaid) for green grass investments in high risk countries (where commercial loans are not available or extremely expensive). It was designed as an access to finance institution and was originally not thought of as a project for migrants. After many years of implementation, it was observed that - especially in the Balkans - a majority of successful investors using the credit facility were highly skilled migrants from the first or second generation who managed to maintain their relation with their country of origin while fully understanding the market and quality requirements of Swiss/European customers as well as accessing respective business networks. Thanks to their comparative advantage in their country of origin, many of the start-ups were successful and created thousands of jobs (estimation in 2012: 19'000). Finance Contact, the managers of the fund, are now increasingly present during diaspora and related business events. The idea is not to make migrants return to their countries. Some choose to return while others manage their business from Switzerland and/or commute. This instrument is not aimed at micro-enterprises, but at small and medium enterprises (SME).

IdEA is a non-partisan, non-profit organization that engages global diaspora communities, the private sector, civil society, and public institutions in collaborative efforts to support economic and social development. Furthermore, the IdEA partnership launched Diaspora Marketplaces, business plan competitions that encourage sustainable economic growth and employment by supporting U.S.-based diaspora entrepreneurs with innovative and high-impact ideas for start-up and established businesses in their regions of heritage. To date, IdEA has launched two African Diaspora Marketplaces, a Caribbean IdEA Marketplace, and recently wrapped up a Latin American IdEA Marketplace competition. Additionally, the U.S. Department of State recently launched an initiative called Networks of Diasporas for Engineers and Scientists (NODES), a partnership between the Department of State, the American Association for the Advancement of Science, and the National Academy of Sciences. For example, on January 16, 2014 Walmart announced that it joined forces with its Florida tomato suppliers and the Coalition of Immokalee Workers (CIW) to strengthen and expand the groundbreaking Fair Food Program. Tom Leech, senior vice president of Global Food Sourcing for Walmart said: "Walmart and our suppliers are committed to strong ethical sourcing standards and every day we work to help ensure the products we sell are produced in a way that provides fair treatment for workers in our supply chain." As agricultural work in the United States has a heavy migrant worker component to it, Walmart's program and others like it have a clear impact in promoting the rights and well-being of migrants and their communities.

The Executive Order also requires compliance measures for large overseas contracts and subcontracts. For a subset of larger federal contracts (exceeding \$500K) performed abroad, it mandates new and tailored compliance plans. Such plans must include:</p> <ul style="list-style-type: none"> <li>○ An awareness program for employees about the anti-trafficking policy and penalties for violations;</li> <li>○ A safe grievance mechanism;</li> <li>○ A recruitment, wage, and housing plan;</li> <li>○ Procedures to prevent and detect subcontractors, at any tier, from engaging in prohibited activities; and</li> <li>○ Cooperation with audits, investigations, and other actions to ascertain compliance.</li> </ul> <p>Government agencies are now required to establish a process to identify industries and sectors that have a history of trafficking-related activities in an effort to enhance compliance on domestic contracts. Additionally, agencies have developed training for the federal acquisition workforce to better identify and monitor potential trafficking in U.S. government contracts.</p>

The MOU seeks to develop cooperation ties between the South African Department of Social Development and the Zimbabwean Ministry of Labor and Social Development.</p> <p>A number of areas of cooperation and information-sharing have been identified, such as care services for vulnerable groups; implementation of international commitments on social development; and capacity building / retention of social welfare and development professionals.</p> <p>With the assistance of UNICEF South Africa and UNICEF Zimbabwe, the South African Department of Social Development and the Zimbabwean Ministry of Labor and Social Development have developed draft Standard Operating Procedures (SOPs) for the tracing, reunification, or alternative care placements of unaccompanied and separated children in South Africa and Zimbabwe. Following these SOPs, two provinces in South Africa (Limpopo and Gauteng) have developed Interdepartmental Action Plans on unaccompanied and separated children in cooperation with civil society partners.</p>
