Vision 2030 Jamaica – National Development Plan, 2008 - 2030

- Designed to guide Jamaica towards developed country status by 2030.
- Vision Statement – “Jamaica – the place of choice to live, work, raise families and do business”.
- Goal 6 Population Sector Plan- “to ensure that international migration is adequately measured, monitored and influenced to serve the development needs of Jamaica”.




