

### A Thematic Meeting on Migration in the Post-2015 UN Development Agenda

Thursday, 5 February 2015 09.00 to 17.30 hrs La Salle V, R3 Level, ILO Building, Geneva

#### **CONCEPT NOTE**

This meeting will assess the progress that has been made in ensuring the inclusion of migrants and migration in the post-2015 UN development agenda—a goal to which the Turkish GFMD Chair is fully committed. The meeting also will help determine how the GFMD can continue to play a proactive and determinative role in achieving this goal.

The 2014 GFMD in Stockholm produced a series of clear recommendations on migration in the post-2015 agenda, guided by two principles: The promotion of the human rights of migrants, and the recognition of migrants and migration as enablers of development. The main recommendations were to include: i) migration in the narrative of the agenda; ii) migration in the means of implementation; iii) migration-related targets under a number of relevant goals; and iv) disaggregated reporting and follow-up to account for migrant status, in order to capture development outcomes for migrants. The recommendations were submitted to the UN Secretary-General, as well as to the co-chairs of the Open Working Group on the Sustainable Development Goals.

Since then, the Open Working Group has issued its report with proposed Sustainable Development Goals and the UN Secretary-General has presented his Synthesis Report on the post-2015 agenda—both of which, to a significant degree, echo the goals set out by the GFMD. In addition, the SG's Synthesis Report suggests annual thematic reviews, with state-led sharing of best practices and the production of annual thematic reports.

This Thematic Meeting will showcase what the inclusion of migration in the post-2015 agenda could mean in practice, by sharing ongoing national examples of initiatives under two of the proposed migration-related targets<sup>1</sup> in the OWG-report; it also will consider how voluntary follow-up could be done in practice. Governments are therefore invited to come prepared to share their experiences related to targets:

8.8 protect labour rights and promote safe and secure working environments of all workers, including migrant workers, particularly women migrants, and those in precarious situations; and

10.7 facilitate orderly, safe, regular and responsible migration and mobility of people, including through implementation of planned and well-managed migration policies

Members of the Global Migration Group will also be asked to share ongoing efforts to review initiatives and commitments in these areas.

<sup>&</sup>lt;sup>1</sup> To focus the discussions, the meeting has been structured around two migration-related targets currently in the OWG-report – i.e., promoting decent work and facilitating well-managed migration. But there are other equally important targets such as 10.c: by 2030, reduce to less than 3% the transaction costs of migrant remittances and eliminate remittance corridors with costs higher than 5%; 17.18: by 2020, enhance capacity building support to developing countries to increase the availability
