chair of the End Child Detention Coalition Australia and the chair of the women, gender and diversity group and focal point on the Global Compact for Migration (GCM) at the Asia Pacific Refugee Rights Network (APRRN). Carolina has ample experience of advocacy with the UN system and is a member of the UN Women's Global Expert Working Group to address the human rights of women in the GCM. She is also a member of the board of the International Detention Coalition (IDC) and the Global Coalition for Migration (GCM).
